

Craft Vending Information, Application, and Contract

Please read through carefully and identify the event you are applying for on the contract and as the subject of email. The Susquehanna Valley Event Center features multiple events throughout the year. The venue is located at: 205 Airport Road, Selinsgrove, PA 17870.

BASIC INFORMATION

- All vending requires prior approval. Unauthorized vending is not permitted.
- These are all-weather events; Deposits are Non-Refundable unless you are not approved, or the event is cancelled or postponed due to COVID or other state of emergency.
- Until further notice, before entering, everyone: Must possess a face mask, Must have their temperature taken at time of entry, Must sign a waiver, and Must practice social distancing in effect at the time.
- Vendor are encouraged to have surface sanitizer on hand for keeping products clean and hand sanitizer for yourself and patrons.
- **Required info**: Web presence/website address and/or photos of products and set up, products for sale, list of events where you have previously vended (references).
- Vendors requests must include the signed contract and required documents emailed <u>sveventcenter@gmail.com</u> and a deposit of 50%, paid with the application, and sent *via PayPal: <u>https://paypal.me/abearspicnic</u> If you are not approved to vend, your deposit will be returned in full, Approved vendors must pay the balance upon entrance to the event. No shows will forfeit their deposit.
- Vendors may <u>not</u> transfer their spot to another person.
- While we do our best to prevent multiple vendors selling the same items, we offer no guarantee
 that insures exclusive rights to any particular items.
- Check in time is <u>after</u> 12:00 Noon and <u>until</u> 3:00 p.m. on the <u>day of event</u>, *No vehicles will be permitted on the field after 3:00 p.m.
- You are expected to shut down promptly, clean up & remove all trash, and check out within one hour of music ending.
- Vendors supply their own tents/setups, and may park vehicle behind their booth. Generators, if necessary, must be operate quietly. No amplified music.
- Craft vendors are <u>not</u> permitted to sell any food or beverages.
- All vendors must agree to follow all rules and regulations of the event, the venue, the state of PA and federal laws. Vendors are strictly prohibited from possessing or selling drugs, weapons, fireworks, or explosives.
- Copyrighted images must be officially licensed merchandise only no bootlegs. Vendors are
 prohibited from selling any unauthorized merchandise bearing the names or likenesses of
 any artist performing at the festival.
- ALL displayed merchandise must be all-age appropriate. ID must be required for any adult items.
